- 1. Meeting called to Order at 5:04
- 2. Quorum Present 10 Directors
- 3. Minutes of Previous Meeting Jan 16,2025 APPROVED
- 4. Business arising from the Minutes
  - Cougar warning signs have been removed at the Summit
  - Igloo Cabin Keeper poster placed Jan 26<sup>th</sup>
  - The newly revised Cabin Etiquette Poster are completed and ready for posting in each Cabin. Thanks to John for coordinating this effort. There was a request to send via email a copy of the new poster - Rob will forward
- 5. REPORTS
- A. Rob gave a brief review of the meeting held Jan 30/25 with Justin Dexter , Travis Mitchell and Tennessee Trent from RS&T and Kim Deane , Les Carter and Rob Richardson
  - Primary reason was to discuss the Partnership Agreement (PA) and FORR concerns.
  - Justin Dexter stated that the Insurance Coverage remains in effect even though the PA expired Dec 31, 2024 . Both

parties are working toward a new PA. Kim will confirm with the Insurer that this is the case

- Justin stated that FORR is responsible for the facilities trails and cabins and not the policing of how the public uses them.
- Liability Insurance Tennessee strongly encouraged FORR to purchase Directors & Officers insurance . stating that many similar group has such insurance
- The 5000\$ annual grant is subject to RS&T budget
- Summer students will be available this year
- B. PARTNERSHIP AGREEMENT (PA)
  - Kim reported of the progress of the PA renewal:
  - Good discussion with RS&T on Jan 30/25
  - Pointed out that certain clauses were not applicable to FORR
  - Revisions have dealt with Services ( 6 in total) provided by FORR, Insurance coverage and Volunteers . Also the removal of non applicable clauses
  - The revisions have been forwarded to Justin Dexter for his review and approval
- C . RISK MANAGEMENT SUB COMMITTEE
  - Kim reported of the progress of the group Bob, Troy, Dan and Kim
  - Update sent to all Board members Jan 11
  - Plan is to write a Risk Management Policy and list specific Risks and FORR Response on how to manage

- It was noted that the list should be short in order to ensure that FORR can respond to the risk
- Recommended that Risk Management / Safety report be on every Board meeting agenda.
