**CABINS ACCESS GIVEN COVID PANDEMIC CONTINUING:** Recreation Sites and Trails, BC has advised that the cabins remain closed for now, but unlocked and available for emergencies.

#### REC SITE 2020 HIGHLIGHTS:

- COVID: Since its outbreak in B.C. in March the Rec Site cabins have been closed, other than for emergency use;
- Rec Site has been heavily used (other than cabins) as people seek outdoor

activities;

- New Igloo Cabin completed - a grand cabin in its own, spectacular basin below Mt. Plewman;
- Accessible Trail (1 km loop around Strawberry Pass Pit) completed with (summer) ramp at Booty's Cabin; grand opening October 6th, 2020;
- New Crowe's Nest Cabin is well advanced having been pre-cut & test-fitted in town, and to be helicopter lifted to site next July 2021. Old shelter still in service this winter (under 'COVID' restrictions); and
- Upgrades at Red Dog and Booty's cabins.
